- **From a Delivery Service including Loansome Doc**

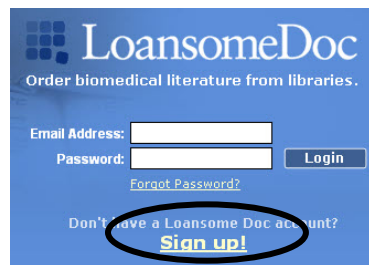
When you need articles on a routine basis, consider using the PubMed **Order** option under the **Send to** menu.

First, register with a delivery service

- The default article service in PubMed is the NLM-sponsored **Loansome Doc** service. Full-text articles may be ordered from participating medical libraries such as the **New York Academy of Medicine Library**.
- To use a document delivery provider other than Loansome Doc, click on **Document Delivery** under **Preferences in My NCBI** and follow the instructions

To Register for Loansome Doc

- Access Loansome Doc at: <https://docline.gov/loansome/login.cfm>
- Click **Sign Up!** And follow the instructions.



During the Loansome Doc registration process, you will have the opportunity to search for a Loansome Doc provider in your area (U.S. and International). Carefully review the displayed information to identify a library that will provide the service you desire as fees and services vary among these libraries. It is recommended you contact the selected library prior to registering.

Ordering Articles

First register for a document ordering service. Then, from the search results screen:

1. Click the check box next to each citation you want to order. You may move to other pages within your results to select additional citations or hold them on the Clipboard before ordering
2. From the **Send to** pull-down menu, select **Order** to access the ordering service
3. Follow the on-screen directions

Full Text and PubMed®

The National Library of Medicine (NLM)'s PubMed® (www.pubmed.gov) does not include copies of journal articles.

However, PubMed does offer links to the full text of journal articles when those links are available.

Access Full Text articles through

- NLM's **PubMed Central** free digital archive of biomedical and life sciences journal literature
- Publishers who offer free or pay-per-view access to articles on their websites
- The **New York Academy of Medicine Library**
- Public libraries
- NLM's **Loansome Doc** or other document delivery service such as the **Document Delivery Department of the New York Academy of Medicine Library**

Links to full text resources from PubMed are available through a service called **LinkOut**. When you click on LinkOut links you leave PubMed and are directed to the full text at an external site. Copyright of these materials remains with the publisher. Users should review all copyright restrictions set forth by the full text provider before reproducing, redistributing, or making commercial use of material accessed through PubMed LinkOut.

Free Articles

Free copies of available articles may be obtained in a number of ways:

- **From PubMed Central**

When searching PubMed, look for “Free Full Text” under **Filter your results** in the right hand column or the **Free Article** link under the citation in the Summary display. This indicates the full-text article is available in PubMed Central, a free digital archive of full-text journal articles maintained by the United States National Institutes of Health (NIH).

To access the article, click on the citation title or “Free Article” link,

and then click on the “Free full text article in PubMed Central” icon. Search PubMed Central directly at: www.pubmedcentral.nih.gov

- **Free from the Publisher**



Many publishers offer free full text. Look for the blue “Free article” at the bottom of the

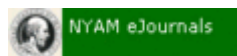
citation on the summary results screen. Alternatively, check “Links to free full text” under **Limits** and **Text Options** to find citations publishers have made available through NLM. To access the article, click the title link to go to the single citation display, and then click the free full text article icon.

You may also visit those publisher’s websites without links or icons, as some publishers provides free access to articles, often after you register as a guest.



- **Through an affiliation with a hospital, university, or other institution**

The New York Academy of Medicine Library is the best option for full text. Use the PubMed link from the library website or a My NCBI **Filter** to view icons



for the library. The icon indicates your library provides a link to the article or has the journal in its collection.

If you do not see an icon for the NYAM library, ask the librarian about how to determine if the NYAM library has access to the journal or the article of interest.

If the NYAM library does not have access to an article you need, ask your librarian about ordering the article from other institutions. Your librarian may also recommend you set up a library filter in **My NCBI** and/or use the **Order** feature from the **Send to** menu.

DO NOT use either “full text” option under **Limits** when working with a library – you may eliminate articles that are available free to you through that library.

- **From Your Local Public Library**

The National Library of Medicine has a special relationship with public libraries. Also, some libraries have copies of medical journals. Your library may have the article or be able to order a copy of it for you using a service called interlibrary loan. Ask your local librarian and/or check your library’s website to find out about interlibrary loan options and whether or not there will be a charge.



Searching PubMed

PubMed users can limit searches to subsets of PubMed. Click **Limits** and select **Links to free full text** under **Text Options**. A search with this limit applied will retrieve citations that have a link to full text when no payment or subscription is required; in some cases registration may be required. You may also select **PubMed Central** under **Subsets**. Talk with your librarian about additional search options.

Article Sources

Copies of articles may also be obtained:

- **Directly from the Publisher**

Journal publishers and related organizations may provide access to articles for a fee or for free, generally following your registration as an individual or guest. When available, icons to these sources can be found on the single citation display.



- **Through LinkOut**

Additional links to articles, both free and for a fee, may be available on the **LinkOut** display. Click on the **LinkOut** plus button below the citation to access the list. Roll the mouse over the sources for more information (e.g. “Full text at publisher’s site, Free Resource”)
